### Economy Still The Number One Story THOMAS COURT APPOINTMENT STIRS LARGE INTEREST

The nomination of Clarence Thomas to the U.S. Supreme Court and stories relating to the condition of the economy were the most closely followed news events of the past four weeks.

Thirty-five percent of the public said they were following news about the economy very closely and 33% said they were following news about Clarence Thomas very closely. Thirty-one percent of respondents polled by telephone by the *Times Mirror Center for the People and The Press* were attentive to news about military base closings around the country, a story with significant economic overtones.

The Thomas nomination has clearly engaged the American public in ways that other important and controversial nominations have not. News about George Bush's latest nominee to the Supreme Court was cited most often by the public as the single story it is following most closely and it was seen as the most important news of the month.

Nearly twice as many Americans are following news of Clarence Thomas very closely as were attentive to news about other recent nominees to the high court. A year ago just 16% of the public said they were following news about Bush's selection of David Souter and four years ago only 17% were following news about Reagan's nomination of Bork.

An important part of the difference in the amount of interest expressed in Thomas vis a vis other nominees is that African Americans are more drawn to Clarence Thomas's story than are whites - 46% of blacks said they were following this news very closely compared to 32% among whites. A year ago blacks showed half as much interest in the Souter nomination (9%) as whites (17%).

African American interest in Thomas has not as yet translated into overwhelming support for Thomas. 45% of blacks favor Thomas' confirmation, 21% are opposed and 34% are undecided. These figures are not very different from the public at large -48% favor, 17% oppose and 35% undecided. Republicans are the only sub-group in the population in which there is clear majority support for Bush's latest Supreme Court nominee (63%). However, it is interesting to note that among people who have followed the Thomas story very closely, 57% favor his nomination compared to 44% among those who have not paid as much attention to the news.

The public demonstrates its expressed interest in the debate about the new high court nominee with a fair amount of knowledge about this story. A 42% plurality think that the current court has a conservative majority while only 9% think that liberals are in the majority. 27% think the court is evenly divided and 22% don't know.

An even larger percentage claim knowledge of Clarence Thomas' political views. 51% think he is a conservative, 16% a liberal, 3% neither and 30% do not know.

#### **Economy A Persistent Interest**

Approximately one-third of the public has expressed a high degree of interest in economic news since the onset of the recession. This is the sixth survey showing a third or more of the public intensely interested in news about economic conditions.

People in the East reported following economic news more closely than people in other parts of the country (42%). However, interest in the other closely followed economic story, military base closings, is equally high in all four major regions of the country.

Sustained public interest in news about economic conditions is coincident with a continuing decline in George Bush's approval ratings. In March, 84% of the public approved of the way the President was carrying out his duties; in May, that percentage slipped to 77% and in the current survey it fell again to 67%. As it has been in other surveys, Bush's approval percentage was lower among those

who followed news of economic conditions very closely (62%) than among those less attentive to this kind of news (70%).

The American public continued to be more interested in White House Chief of Staff John Sununu's transportation troubles than they typically are of news about Washington leaders with job-related problems. Twenty-six percent said they were following this story very closely, compared to the 24% recorded in *Times Mirror's May News Interest Index*. By way of comparison with capitol scandals of the recent past, two years ago just 15% were very closely following the ethics committee investigation that led to House Speaker Jim Wright's resignation.

Another "Washington story", the alleged Reagan 1980 campaign deal with Iran also captures the close attention of one in four Americans (24%). However, unlike interest in the Sununu story which is bipartisan, interest in allegations that the hostage release was held up until after the 1980 election campaign is twice as high among Democrats (32%) as among Republicans (16%).

The Supreme Court decision allowing laws that ban doctors employed at federally funded agencies from discussing abortion was followed very closely by 25% of the public. News of the decision was of more interest to women (28%) than to men (20%) and this was the only story covered in the poll that interested people under 30 years of age as much as it interested older people. Young people's interest in the story was sharply higher among young women than among young men (30% vs. 17%).

Important international news stories did not attract a lot of public attention this month. President Bush's decision to lift the trade embargo on South Africa was followed very closely by 17% of the public, Yeltsin's election victory and subsequent visit to the United States attracted the attention of 12% and the conflict in Yugoslavia was the least followed story of the ten tested in the Times Mirror survey at 11%.

The only major domestic story to rank so low in public interest was the debate in Washington about the new civil rights bill. Eleven percent of the public reported following these stories very closely. Interest was higher among African Americans (33%) than among whites (9%), yet attentiveness to the civil rights debate among blacks was lower than the amount of attention blacks paid to South Africa (38%) or to news about the condition of the U.S. economy (40%).

#### Press Ratings Slip

Public evaluations of press performance were lower than average this month. Just 14% of Times Mirror respondents said the press was doing an excellent job in covering the story that they were following most closely and as many as 39% rated coverage as only fair or poor. Typically, about one in four rate press coverage as excellent and critical ratings are below 25%. In our view, this ratings fall off has more to do with the nature of the stories that dominated the news this month, than it does with a meaningful shift in sentiment about news media.

The public is consistently less positive about news coverage when the top stories of the month do not deal with fast breaking news events and when they deal with either controversial social issues or with the personal or ethical problems of people in high places. All of these criteria apply to the top news stories of the past four weeks and may account for the lower media ratings obtained.

In order to assess public evaluations of the news media, Times Mirror asked its nationally representative sample to judge the *fairness* of reporting on abortion, civil rights, John Sununu and Clarence Thomas.

On the two social issues, the poll found the public divided as to whether the press is fair. Fortythree percent felt the press is generally fair in the way it reported on the abortion controversy, while 43% thought that it is one-sided. Similarly, 49% thought that reporting on civil rights is generally fair and 36% saw it as one-sided.

In each case people who see the press as one-sided split about evenly with regard to the nature of the perceived press bias. Of the 43% who see press bias on abortion, 19% see the bias in the pro-life direction, which is matched by 18% who see it in the pro-choice direction. Similarly, of the 36% who see bias in civil rights news reports, 16% see it as a pro-affirmative action bias, while 15% see it as favoring the anti-affirmative action side.

To the extent that the public sees press bias, it sees it as running counter to the respondent's own views. That is, pro-choice people who see a bias on abortion think that it is in the pro-life direction and vice versa. The same pattern is evident for perceptions of civil rights bias.

In short, while many people see press bias on these two divisive issues, there is no indication that *on balance* the press is perceived as biased in a particular direction. What is clear is that it is difficult for the press to appear dispassionate in the eyes of people who hold strong views about such divisive issues.

Opinion about the fairness of press coverage of John Sununu and Clarence Thomas is different than opinion about reporting on social issues. Far fewer people see the press as unfair, but among those who do, the predominant opinion is that the press is too critical of these men, not too protective.

By a 52% to 26% majority, the public sees the press as fair in the way it reports about Sununu's transportation troubles. Of the 26% who regard the press as unfair, 20% think the press is too critical of the White House Chief of Staff, while just **3%** think the press is too supportive.

A fifty-eight percent majority think the press has been fair to Clarence Thomas, but of the 20% who feel that Judge Thomas is being dealt with unfairly, 18% say the press is too critical and 1% think it is too supportive. It is of note that even among those who oppose Thomas' confirmation, the predominant criticism is that the press is too critical (12%), not too supportive (6%).

## SURVEY METHODOLOGY

The survey results are based on telephone interviews conducted among a nationwide sample of 1,212 adults, 18 years of age or older, during the period July 11-14, 1991. For results based on the total sample, one can say with 95% confidence that the error attributable to sampling and other random effects is plus or minus 3 percentage points. In addition to sampling error, one should bear in mind that question wording and practical difficulties in conducting surveys can introduce error or bias into the findings of opinion polls.
