# Hispanics of Argentinean Origin in the United States, 2011

An estimated 242,000 Hispanics of Argentinean origin resided in the United States in 2011, according to the Census Bureau's American Community Survey. Argentineans in this statistical profile are people who self-identified as Hispanics of Argentinean origin; this means either they themselves are Argentinean immigrants or they trace their family ancestry to Argentina. Argentineans are the 14th-largest population of Hispanic origin living in the United States, accounting for 0.5% of the U.S. Hispanic population in 2011. Mexicans, the nation's largest Hispanic origin group, constituted 33.5 million, or 64.6%, of the Hispanic population in 2011.<sup>1</sup>

This statistical profile compares the demographic, income and economic characteristics of the Argentinean population with the characteristics of all Hispanics and the U.S. population overall. It is based on tabulations from the 2011 American Community Survey by the Pew Hispanic Center, a project of the Pew Research Center. Key facts include:

- *Immigration status*. About six-in-ten Argentineans (62%) in the United States are foreign born compared with 36% of Hispanics and 13% of the U.S. population overall. About six-in-ten immigrants from Argentina (60%) arrived in the U.S. in 1990 or later. About half of Argentinean immigrants (49%) are U.S. citizens.
- *Language*. Roughly three-quarters (74%) of Argentineans ages 5 and older speak English proficiently.<sup>2</sup> The other 26% of Argentineans report speaking English less than very well, compared with 34% of all Hispanics.
- *Age.* Argentineans are younger than the U.S. population but older than Hispanics overall. The median age of Argentineans is 35; the median ages of the U.S. population and all Hispanics are 37 and 27, respectively.
- *Marital status*. Argentineans ages 15 and older are more likely to be married (56%) than Hispanics overall (43%) and the U.S. population overall (48%).
- *Fertility*. About one-in-ten (7%) Argentinean women ages 15 to 44 gave birth in the 12 months prior to this survey. That was similar to the rate for all Hispanic women—8%—and the overall rate for U.S. women—6%.

- *Regional dispersion*. Argentineans are concentrated in the South (39%), mostly in Florida (24%) and the West (30%), mostly in California (23%).
- *Educational attainment*. Argentineans have higher levels of education than the Hispanic population overall and the U.S. population overall. Four-in-ten (40%) Argentineans ages 25 and older—compared with 13% of all U.S. Hispanics and 29% among the U.S. population—have obtained at least a bachelor's degree.
- *Income*. The median annual personal earnings for Argentineans ages 16 and older were \$30,000 in the year prior to the survey—greater than the median earnings for all U.S. Hispanics (\$20,000) and similar to the median earnings for the U.S. population (\$29,000).
- *Poverty status.* The share of Argentineans who live in poverty, 11%, is lower than the rate for the general U.S. population (16%) and the rate for Hispanics overall (26%).
- *Health Insurance*. Almost one-quarter of Argentineans (22%) do not have health insurance compared with 30% of all Hispanics and 15% of the general U.S. population. Additionally, 11% of Argentineans younger than 18 are uninsured.
- *Homeownership*. The rate of Argentinean homeownership (53%) is higher than the rate for all Hispanics (46%) but lower than the 65% rate for the U.S. population as a whole.

#### **About the Data**

This statistical profile of Hispanics of Argentinean origin is based on the Census Bureau's 2011 <u>American Community Survey</u> (ACS). The ACS is the largest household survey in the United States, with a sample of about 3 million addresses. The data used for this statistical profile come from 2011 ACS Integrated Public Use Microdata Series (<u>IPUMS</u>), representing a 1% sample of the U.S. population.

Like any survey, estimates from the ACS are subject to sampling error and (potentially) measurement error. An example of measurement error is that citizenship rates for the foreign born are estimated to be overstated in the Decennial Census and other official surveys, such as the ACS (see Jeffrey Passel. "Growing Share of Immigrants Choosing Naturalization," Pew Hispanic Center, Washington, D.C. (March 28, 2007)).
